## Board of Trustees Approves Change in Fiscal Year


In June 2022, Women Aware's Board of Trustees approved a change to the agency's fiscal year from the calendar year (January 1 to December 31) to a fiscal year (July 1 to June 30).

Given that the New Jersey Department of Children and Families, Division on Women, Women Aware's largest funder, moved from a January 1 to July 1 fiscal year start, Women Aware's accountant, auditor, and Board of Trustees agreed this was the proper course of action for the agency.



## Need for Shelter Up 58%

Demand for emergency shelter continues to rise, and the lethality of cases is worsening. Advocates are seeing an increase in reports of strangulation and sexual assault and increasing violations of restraining orders.

As the only domestic violence shelter in Middlesex County, Women Aware has gone from sheltering, on average, 194 individuals/year pre-pandemic to sheltering 307 in FY 2023, an increase of 58%. Bednights of shelter/year soared from 8,063 pre-pandemic to 22,016 in FY 2023. Survivors shelter longer because affordable housing is scarce. Across programs, the number of victims served jumped 56% from 1,824 in 2019 to 2,844 in FY 2023.





Staff utilize a language line to actively communicate with clients in over 200 additional languages, including Arabic, Cantonese, Mandarin, Farsi, Telugu, and Russian.

Women Aware is the lead agency of the Middlesex County Family Justice Center At the Middlesex County Family Justice Center (FJC), our shared goal is to establish a one-stop center where survivors can access services from multiple providers and tell their story once, reducing the risk of retraumatization. 
