MESSAGE FROM CEO PHYLLIS YONTA



Since the COVID-19 pandemic, a historic increase in the number of victim-survivors requesting domestic violence services, and the complexity of cases, are presenting financial challenges to Women Aware. We diligently pursue diversified sources of funding to uphold our commitment to provide free and confidential services to the most vulnerable members of our community. We continue to shelter survivors and their children for months due to challenges finding affordable housing. More clients report extremely low to no income, which makes it difficult to sustain any kind of housing, while clients with some income are ineligible for Welfare Housing benefits. Even so, our Housing Navigator supported the successful transition of 42 families from emergency shelter to independent living between July 1, 2023 and June 30, 2024.

In response to high incidents of non-fatal strangulation in Middlesex County, Women Aware created a **High-Risk Advocate Program** to answer the immediate and long-term needs of victims in partnership with the Middlesex County Prosecutor's Office (MCPO), law enforcement and five area hospitals. In just the last 12 months, 9% of our clients, 266 individuals, were victims of non-fatal strangulation.


Having welcomed 789 victim-survivors through its doors in FY 2024, the **Middlesex County Family Justice Center** (FJC) recently added four new community partners, including the Catholic Charities-Diocese of Metuchen, Prevention Resources, Dress for Success Central New Jersey and the Reformed Church of Highland Park Affordable Housing Corporation. These partnerships further expand the FJC's capacity to provide victims of domestic violence, sexual assault and stalking with direct access to law enforcement, legal, immigration, housing, healthcare, social and human services and other resources.

Knowing "We are Better Together," Women Aware and the Middlesex County FJC hosted the first **Middlesex County Domestic Violence Conference** in October. Nearly 140 partners, legal advocates, DCP&P workers, members of the NJ Coalition to End Domestic Violence, law enforcement, MCPO staff, mental health professionals, victim-survivors and our own Women Aware team assembled to network and learn about traumainformed care, coercive control, victim confidentiality, giving litigants agency and non-fatal strangulation.




